MTFX USA INC. e-Sign Consent Agreement

IN ORDER TO REGISTER AND UTILIZE MTFX USA'S SERVICES, MTFX USA MUST PROVIDE CERTAIN DISCLOSURES REQUIRED BY LAW. MTFX USA CAN ONLY PROVIDE THESE DISCLOSURES AND OTHER INFORMATION ELECTRONICALLY IF THE USER CONSENTS.

1. CONSUMER CONSENT

By checking the "I agree to the terms and conditions of the E-Sign Consent Agreement," you hereby affirmatively consent and agree that MTFX USA may provide all communications, disclosures required by law and other information about your legal rights and duties ("Communications") by electronic means, either by email or by making it available to you when you log in to the MTFX USA website using your username and password. All Communications that MTFX USA provides to you electronically will be sent to the e-mail address you specify in your user profile. You understand and acknowledge that if you do not consent to electronic delivery of all information, you cannot use the MTFX USA service. All information that is provided electronically shall be deemed to be provided "in writing." You should print or download for your records any Communications that are important to you.

2. WITHDRAWAL OF ELECTRONIC CONSENT

3. UPDATED RECORDS

4. SYSTEM REQUIREMENTS

In order to access and retain electronic records and disclosure, you will need the following:

An Internet browser that supports 128-bit encryption, such as Internet Explorer versions 8.0 or above or Firefox 3.0 or above. The browser must have cookies enabled.

5. A VALID EMAIL ADDRESS

Software capable of opening PDF attachments and interfacing with our systems.

A personal computer, operating system and telecommunications connections to the Internet capable of supporting the foregoing.

Sufficient electronic storage capacity on your computer's hard drive or other data storage unit, to store copies of your records.

A printer that is capable of printing from your Internet browser and email software, if you desire paper copies of your records.

6. FEDERAL LAW
